Minimizing MRO Chemical Risk

SARA: Superfund Amendments and Reauthorization Act; Title III: Emergency Planning and Community Right-To-Know Act (EPCRA); Section 313: Toxics Release Inventory

The SARA Section 313 Toxics Release Inventory Reporting Program is a federal requirement for facilities that use certain toxic chemicals in quantities above threshold levels and have at least 10 employees. They are required by law to report annually on the use, release, and disposal of those chemicals, and to compile data into a Toxics Release Inventory (TRI) Report.

Managing the annual SARA Title III report for a large industrial site can be a time-consuming and costly practice. For this reason, CRC developed our SARA Section 313 Chemical Reporting Program to improve the management of MRO chemicals, reduce costs surrounding the acquisition, use and disposal of these chemicals, and keep you in compliance with Federal regulations. Our regulatory department will record and monitor these chemicals for products you buy through CRC and provide totals for use in your final TRI report.

A few key questions to consider...

- What are the reportable limits for my facility?
- How are we tracking MRO chemical usage across the entire site?
- Are unauthorized MRO chemical purchases being made on the shop floor?
- How are we tracking formula changes and updating Safety Data Sheets for MRO chemicals used?

Uncertainty on any of these issues could be putting your facility at risk! CRC can help you measure and identify chemicals used in your facility and help you mitigate risk.

3 STEP REPORTING PROCESS



1. Product Survey and Application Analysis

Contact your local CRC Regional Manager to set up a review of your current maintenance chemical product use. CRC will consolidate products where appropriate to one of our SKUs so we may provide you with complete tracking of the TRI-listed chemicals for your facility's annual report.



2. Track Your Chemical Consumption

CRC, in partnership with your local distributor, will track your annual consumption of chemicals listed on the EEPA's TRI toxic chemical list. The current list contains 775 individually listed chemicals and 33 chemical categories.



3. Chemical Ingredient Report Is Generated

Because you switched to CRC maintenance chemicals, we can provide a complete account of all chemical ingredients used by your facility required to be reported as SARA 313 TRI Toxic Chemicals. CRC will provide a complete list of all chemical ingredients which are reportable as SARA 313 Toxic Release Inventory. Use our list to complete your facility's SARA reporting.
